
Properties can be let if they have an energy rating from A to E.

Energy rating and score

Primary energy use

The primary energy use for this property per year is 228 kilowatt hours per square metre (kWh/m2).

How this affects your energy bills

An average household would need to spend £711 per year on heating, hot water and lighting in this property. These costs usually make up the majority of your energy bills.

5. Replace single glazed windows with low-E double glazed windows	£3,300 - £6,500	£55
